

Financial Statement Disclosures for June 30, 2024

The following is the Public Trust Advisors, LLC (Fund Administrator) interpretation of your disclosure responsibilities related to your participation in the North Carolina CLASS local government investment pool. The information provided may be required for the financial reporting of Participants in North Carolina CLASS. Participants should consult their auditing and accounting professionals regarding their specific reporting requirements.

GASB 79 Disclosure

According to the Governmental Accounting Standards Board (GASB), in order for an investment pool to qualify for the use of amortized cost accounting for financial reporting purposes, it must meet all of the criteria listed in GASB Statement No. 79. North Carolina CLASS is managed as stable value NAV pool but does not meet all of the specific criteria outlined in GASB 79 Paragraph 4, therefore North Carolina CLASS Participants should report their investments in the pool at fair value. The value of your investment in North Carolina CLASS as stated on your June 30, 2024 statement should be used as the fair value of your investment.

GASB 72 Fair Value Hierarchy Reporting for North Carolina CLASS

North Carolina CLASS measures its investments at fair value and therefore a Participant's investment in the pool is not required to be categorized within the fair value hierarchy for purposes of Paragraph 81a(2) of Statement 72*.

GASB 40 Note Disclosure Requirement for North Carolina CLASS

Credit Quality Disclosure

North Carolina CLASS is rated by S&P Global Ratings. The current rating is 'AAAm'.

Custodial Credit Risk Disclosure

North Carolina CLASS is an external investment pool and therefore is not subject to custodial credit risk; your investment in the pool is exempt from the reporting requirement.

Interest Rate Risk Disclosure

The dollar weighted average days to maturity (WAM) of North Carolina CLASS at June 30, 2024, was 37 days and the weighted average life (WAL) was 76 days.

Weighted Average Maturity (WAM) calculates the average number of days until maturity for a portfolio of securities. WAM uses the next interest rate reset date, call date or put date in the calculation and therefore should always be less than or equal to weighted average life (WAL).

Weighted Average Life (WAL) calculates the average number of days until maturity for a portfolio of securities using the stated maturity date for all securities, including variable rate, callable or puttable securities.
